RALEIGH --- The State Banking Commission convened its regular meeting on Wednesday, July 20, 2011, at 9:00 A.M. in the Hearing Room of the Office of the Commissioner of Banks, 316 W. Edenton Street, Raleigh, North Carolina.

The following applications were approved:

1. Application by Harrington Bank, FSB, Chapel Hill, North Carolina, for authority to convert from a federal savings bank to a North Carolina State-chartered commercial bank to be known as Harrington Bank.
2. Application by RBC Bank (USA), Raleigh, North Carolina, to establish a new non-depository trust company to be known as RBC Trust Company (NC) LLC, Raleigh, North Carolina, and for authority to then sell RBC Trust Company (NC) LLC, to Renasant Bank, Tupelo, Mississippi.
